Terms and Conditions

- Deposit and monthly fee of real time quote service plan must be paid in advance.
- The fee of real time quote service plan is charged on a calendar month basis and will be debited from your trading account on the first working day of each month. Should there be insufficient fund in your account on due date, we reserve the right to terminate your access at the end of the month without further notification. The deposit of real time quote service plan will be refunded to your trading account to settle the outstanding fee.
- To terminate the real time quote service plan, please return your completed RTQ termination form by fax or visiting any branch of Luk Fook Financial to **notify us at least five working days before the end of a month**. The application will be effective from the first day of the following month onwards. The deposit of real time quote service plan will be refunded to you.
- The real time quote service plan is provided from different sources. Subscribers are responsible for the risks of using the information provided. Our company shall not be liable for any loss or damage arising from any inaccuracies or omissions.
- If you would like the snapshot quote service, you would need to apply for it in advance. After we have processed your request, there will be a monthly prepay service charge, based on the number of clicks you apply for. Fees are HK\$25 per 100 clicks, by increment of 100 clicks. Unused quota won't be carried over to the next month. Once you have activated the service, the same number of clicks will be assigned to you every month until you give us a change/cancel instruction.
